## PROMISSORY NOTE

Such yearly payments of principal and interest shall commence on August 29, 2004, and shall continue on the same day of each year thereafter, until August 29, 2019, when all principal and unpaid interest then outstanding under this Note shall become due and payable.

In case of default in the payment of any installment of interest due under this Note within 30 (10) days of when due, or in case of default in the terms or conditions of any other documents which may from time to time be given as additional security herefor, and if any such default is continued for a period of fifteen (15) consecutive days after receipt by Borrower of notice in writing from the Note holder specifying the nature of such default, the Note holder shall have the option to declare due and payable at once the entire unpaid principal balance hereof and any accrued interest.

Borrower and all other parties liable herefor, whether principal, guarantor, endorser or otherwise, hereby severally waive demand, notice, presentment and protest.

The undersigned agrees to pay all expenses of collection of this Note, including reasonable attorneys fees incurred in any court proceedings.
